Minutes of the Annual General Meeting (AGM) of the West Nipissing Community Health Centre, held on Monday, June 25, 2018 at 6:30pm in Sturgeon Falls, at WNCHC, 68 Michaud Street

1. Welcome – President Dan Roveda welcomes the participants. He thanks attendees and board members for participating in this annual meeting. 6. Report of the President

- Mr. Roveda gives an overview of the accomplishments of 2017-2018. He mentions that one of the projects was the renovation of the gymnasium which is now completed, which will allow the expansion of community programs.
- He mentions the end of the term of Louise Gauthier, who is completing 7 years of service as a member of the WNCHC: A term of one year to replace another member, then 2 complete terms. Mr. Roveda thanks Louise and mentions that her experience in the health field was an asset for the Centre.
- He also wishes to thank Dr. Ferguson who is retiring shortly. He adds that Dr. Ferguson is highly respected in the community and will be missed.
- He also highlights the quantity and quality of work accomplished by the staff. He thanks Guy Robichaud for the excellent job, as well as the board members and the employees.

7. Executive director's report

Guy gives an overview of new things that happened in 2017-2018, mainly partnerships, and encourages people to review the annual report for more details.

The overview includes:

- Many changes resulting from the move to the permanent site at the end of 2016. The spaces in the old site limited the opportunities.
- The theme for 2017-2018 is growth. The Centre accepted new clients, reaching 81% of the target. The Centre also launched new programs throughout the year.

New partnerships include:

- The Alzheimer Society
- LHIN integrates home care coordinator in WNCHC team
- The Arthritis Society via the Telemedicine service
- Children's Aid

Guy introduces the staff members present at the meeting and acknowledges their outstanding work and expresses his appreciation for the health care professionals.

Guy thanks the Board for its commitment and support, as well as the volunteers for their dedication to programming.

8. Presentation by Stéphanie LeClair from the Alzheimer Society: programs and services.

Stéphanie LeClair and Anik Roy of the Alzheimer Society present the Alzheimer Society's new features and the programs and services they are able to offer to the community of West Nipissing, in partnership with the WNCHC.

Following the presentation, Guy mentioned that the short and medium-term goal is to integrate the Alzheimer's Society's modules into the WNCHC's Seniors Day Program to further meet local needs.

9. Financial Report
